# Australia's VET sector

4.5 million students annually

Qualifications/skill sets delivered by >4600 providers

- 4118 ASQA regulated RTOs (approximately 89%)
- 507 Vic/WA regulated RTOs (approximately 11%)

Larger providers

- Top 30 providers represent >1m students, or 25% of all students
- Top 1100 providers (almost 25% of total providers) represent almost 90% of all students

Smaller providers

- Very large proportion of about 2000 providers (around 40% of total providers) with 100 or fewer students
- Approximately 3500 providers (approximately 75% of total providers) represent only 10% of all students

# Community based adult education providers

## ASQA's regulatory activity

- ASQA regulates **195** Community Based Adult Education Providers (**4%** of all providers)
- In 2015, there were **81,490** enrolments of these providers across all states and territories (**3%** of total enrolments)
- ASQA has conducted **62** audits of community based adult education providers from 2014 to 2016

## 2016-17 – In review

### Key ASQA priorities

- Development and roll out of student centred audit model
- Enhancement of risk model
  - Compliance history and provider profile replaced ‘risk rating’ of providers
  - Use of dashboards for risk indicators
- VET FEE-HELP program

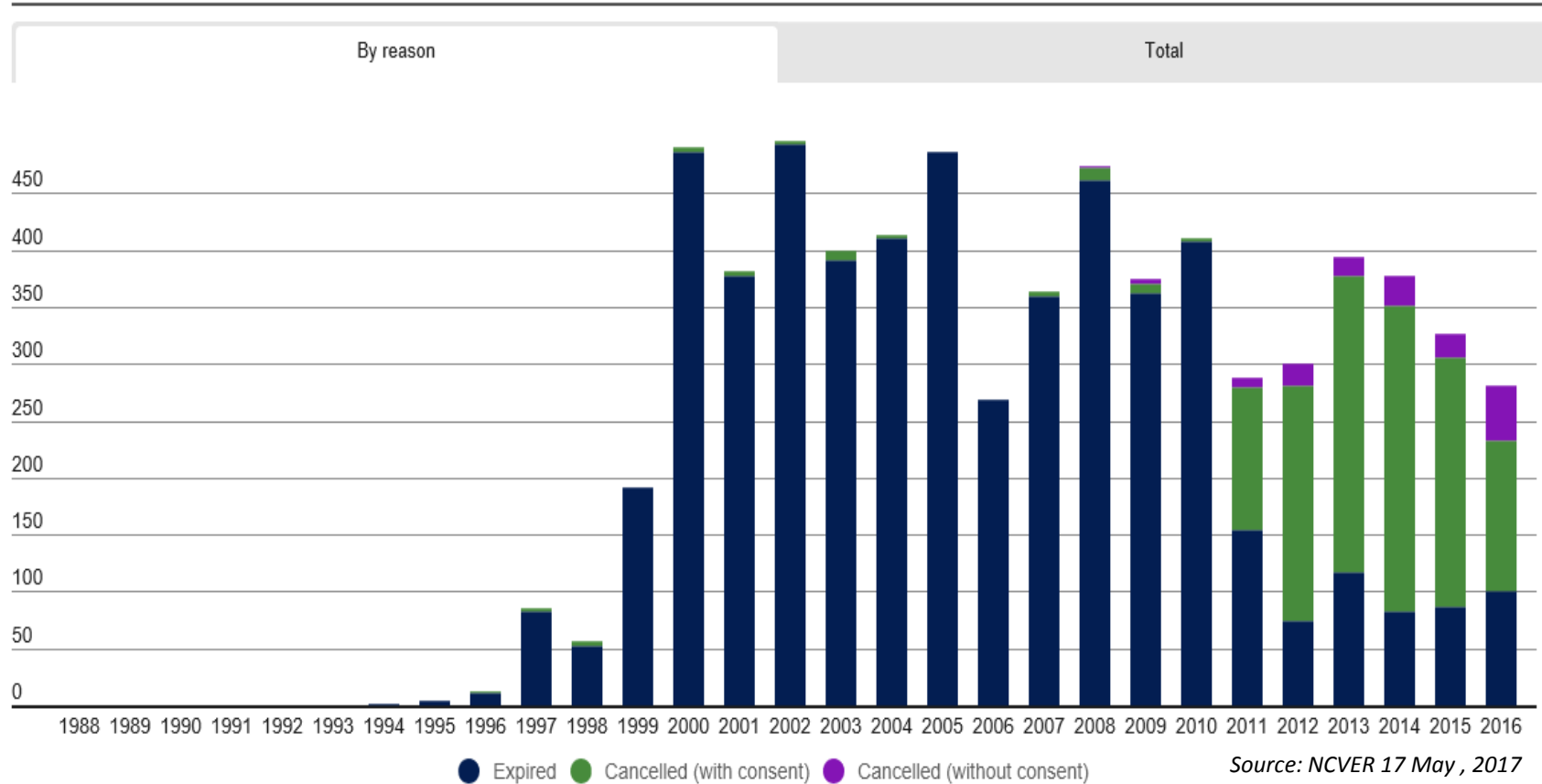
## 2016-17—In review

### ASQA regulatory decisions

Type of decision	Number of decisions
Cancellation	232
Suspension	205
Written notice of intention to cancel or suspend	800
Other administrative sanctions	172
<b>Total</b>	<b>1409</b>

# ASQA's Regulatory Strategy 16-17: Focus areas

## 1. Learner Protection

Some poor recruitment and enrolment practices are evident

Learners may not be placed in suitable courses

Brokers are often a problem

## 2. Amount of training

Unduly short course durations are a threat to quality

## 3. Capability of trainers and assessors

Many RTOs struggle with assessment



## 1. Learner protection—key considerations

- Is the training product (industry outcome and AQF level) appropriate for the prospective student?
- Will supervisory and workplace experience requirements be met?
- Does the student understand all aspects of the training?

## 2. Amount of training – Unduly short course duration

- Major research project of Australian and international treatment of ‘time’ within VET – Strategic review conducted
- 3000 RTO websites examined to determine length of advertised courses
- While there are significant variations between training packages and different industry areas, there is a strong basis to conclude course duration is below that required to obtain and demonstrate necessary competencies

# Course duration strategic review

## Recommended Strategy

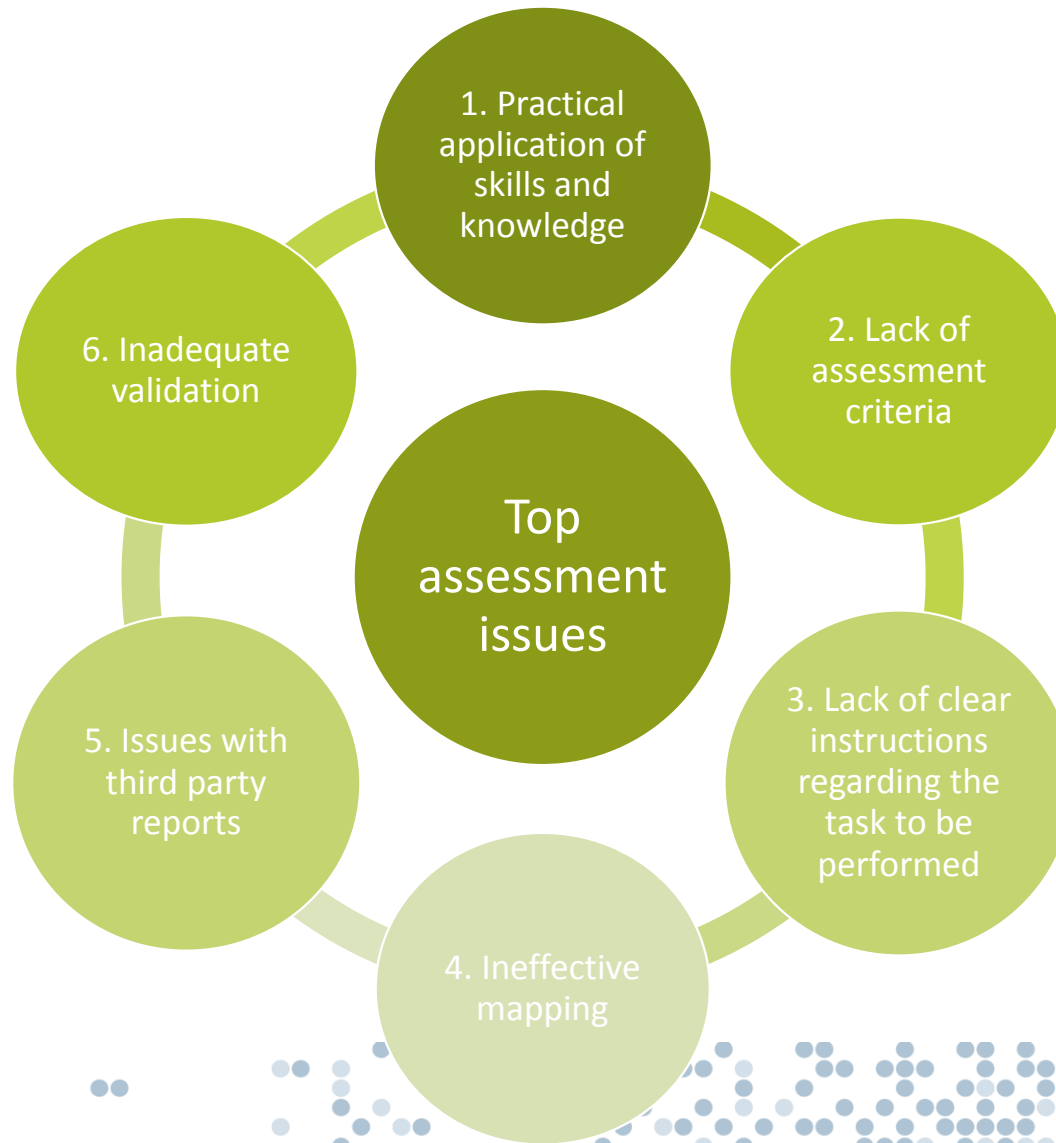
- Standards for RTOs be amended to define 'amount of training' to include supervised learning and assessment activities
- Enable training package developers to respond to industry-specific risks by setting mandatory requirements, including an amount of training
- Enhance transparency by requiring public disclosure of the amount of training in product disclosure statements, presented in a consistent way to enable comparisons across courses

# Unduly short course duration - Key considerations

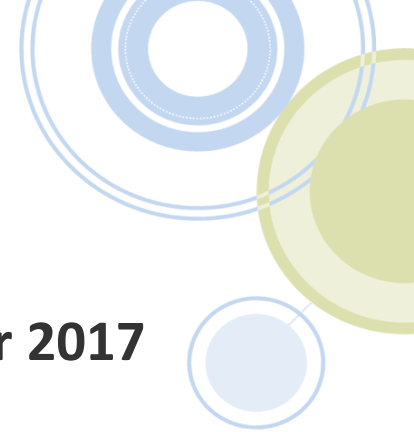
Standards for RTOs (Clauses 1.1. & 1.2)

- Are the training and assessment strategies and practices, consistent with the requirements of training packages and VET accredited courses, and enable each learner to meet the requirements for each unit of competency or module in which they are enrolled?
- Is the amount of training sufficient for the student to gain the required skills and competencies to be certified as competent?
- Does the training provide enough time to absorb essential knowledge and skills in a variety of contexts?

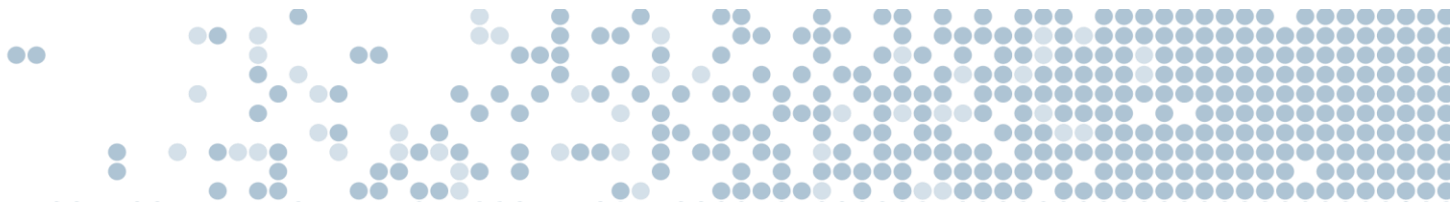

## Training and Education (TAE) Training Package



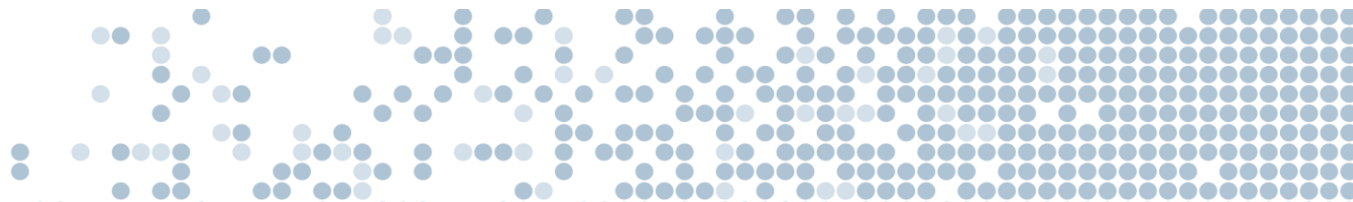
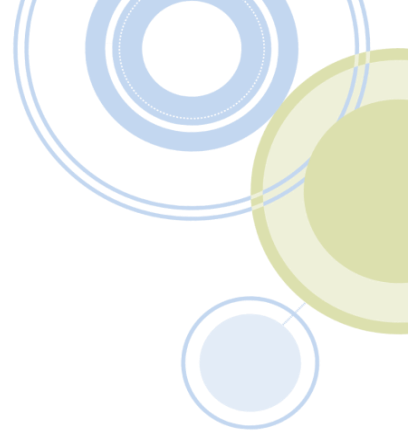
- TAE Training Package transition period ends **5 October 2017**
- Increased evidence requirements
- Increased scrutiny of each application
- Rationale for strengthened application assessment processes:
  - issues with assessment across sector
  - trainer and assessor capability to conduct assessment
